Name of the Definition	Description of the Definition
100 Club	A non-profit organization that provides assistance, from private contributions, to the families of seriously injured/deceased Correctional Officers, Detention Officers and law enforcement personnel. The Director appoints a 100 Club Liaison.
Absconder	A juvenile probationer or parolee who hides, conceals, or absents him/her with the intent to avoid legal process or authorized control.
Absence Without Authorized Leave (AWOL) or Runaway	Occurs when a juvenile leaves a program site or activity without permission.
Absent Without Approved Leave	An employee who, without authority, absents him or herself from his/her place of duty for three consecutive days or more; may be considered abandonment of the job position and result in disciplinary action, up to and including dismissal.
Absent Without Leave	An employee who absents him or herself from his/her place of duty at which s/he is required to be at the expected time; may result in disciplinary action.
Absolute Discharge	A release from ADJC jurisdiction and supervision when the Department personnel decide that there is a reasonable probability that the juvenile will observe the law and, if at liberty, will not be a threat to public safety.
Abuse	The infliction or allowing of physical injury, impairment of bodily function or disfigurement, or the infliction of or allowing another person to cause serious emotional damage as evidenced by severe anxiety, depression, withdrawal, or untoward aggressive behavior and in which emotional damage is diagnosed by a medical doctor or psychologist and is caused by the acts or omissions of an individual having care, custody and control of a child. Abuse shall include inflicting or allowing sexual abuse, sexual conduct with a minor, sexual assault, and molestation of a child, commercial sexual exploitation of a minor, sexual exploitation of a minor, incest, or child prostitution. ARS §8-201.
Academy Commander	An employee who is responsible for the agency pre-service academy and its operations and who directs and manages the Field Training Officer Program for its adherence, quality assurance, and training.
A Catastrophic Event	Is any natural or manmade incident, including terrorism, that results in extraordinary levels of mass casualties, damage, or disruption severely affecting the population, infrastructure, environment, economy, national morale, and/or government functions.
Access	The National Crime Information Center (NCIC) Advisory Policy Board defines two types of access: a. Direct - Terminal access and dissemination within an agency; and b. Indirect - Non-terminal access outside of an agency that has direct access.
Active Duty	Duty under a call or order to active duty under a provision of law referred to in section 101(a)(13)(B) of title 10, United States Code.
Activities of Daily Living (ADL)	These activities generally refer to ambulation, bathing, dressing, feeding, and toileting.
Activity	Drive to move and act (running, chewing and digging).
ADJC Employees	Employees, volunteers, interns, and service providers under contract with ADJC.

ADJC Juvenile	Juvenciles under 18 years of age who have been adjudicated to ADJC who can either be under community or secure facility supervision.
ADJC Public Speakers	Employees, volunteers, interns, consultants, and any other public speakers designated by the Chief of Communications and Legislative Affairs or designee to represent ADJC.
ADJC Symbols	Refer to the words Arizona Department of Juvenile Corrections, the letters ADJC, the institution seal, the name or any visual representation of the institution, ADJC Positive Behavioral Interventions and Supports (PBIS), along with all other proprietary, trademark, or other identifiers of the institution, its programs, auxiliaries, and self-support operations.
Adjudicated	Juvenile hearings are considered civil matters not criminal. Adjudicated is the juvenile equivalent of the adult criminal finding of guilty.
Adjudicated Offense	Charges heard during juvenile court petition hearing or "finding of fact" before a Hearing Officer for a disciplinary hearing or parole revocation.
ADOA	Arizona Department of Administration.
ADOA Director	The Director of the Arizona Department of Administration.
Administrative Investigation	A comprehensive query into a complaint or allegation conducted by an assigned supervisor or by the Investigations Bureau into the actions or behavior of an employee.
Administrative Investigation Extension Memorandum	A written request for an extension to complete an administrative investigation. This extension memorandum shall become part of the administrative investigation.
Administrative Investigation Report Form	A document which will be completed on any misconduct allegation of employee, volunteer, interns, and service providers under contract with ADJC.
Administrative Manager	An employee designated by the Records Unit Supervisor to serve as the Formbase representative for the agency and as point of contact for Formbase Power Users.
Administrative Memo (A-Memo)	A temporary written instruction issued in memo form and signed by the Director. Director's instructions are issued to provide immediate instructions in critical/urgent situations.
Admission	When the Mental Health Team Coordinator or designee determines a juvenile who goes to Separation voluntarily or is sent there by an employee meets the criteria to remain in the Separation Program for de-escalation and stabilization.
Adulterated Specimen	A specimen that has been altered or a substitute provided by the candidate or employee to be submitted as a specimen to be drug tested, and may include the use of a masking agent to prevent the detection of drug use in the testing sample.
Agency Personnel	For the purposes of this procedure sworn, certified ADJC Special investigators trained and certified by Arizona Peace Officer Standards and Training (AZ-POST), Parole Officers, and agency personnel directly supervising the activities or movement of juveniles committed to the Department.

Aggregate Dollar Amount	Purchase price, including taxes and delivery charges, for the term of the contract and accounting for all allowable extensions and options.
Air Scenting	The process by which the service doc examines a subject (person or object) through the dog's sense of smell (olfactory examination).
ALECA	Arizona Law Enforcement Canine Association
Alcohol	Intoxicating agent in beverage alcohol, ethyl alcohol, or other low molecular weight alcohols including methyl and isopropyl alcohol and may include any medication that contains alcohol.
Americans With Disabilities Act (ADA)	A federal civil rights law requiring employers to provide qualified individuals with disabilities an equal opportunity to benefit from the full range of employment related opportunities available to others. Gives civil rights protections to individuals with disabilities that are like those provided to individuals on the basis of race, sex, national, origin, and religion. It guarantees equal opportunity for individuals with disabilities in employment, public accommodations, and telecommunication.
Anticipated Treatment Completion Date (ATCD)	The anticipated data for a juvenile to complete the required treatment programming based on the juvenile's own treatment needs and progress through the Stages of Change.
APO	The Agency Privacy Officer who is generally designated by ADJC to facilitate adoption of privacy safeguards and compliance for all personal identifying information acquired, used, disclosed or maintained by the agency. The APO works collaboratively with the HIPAA Compliance Officer, as applicable, the ISO and the SISPO to adopt and carry out the provisions of the SISPO Information Security Incident Management Policy (P900) and its standards (5905 and 5910). The APO will generally oversee the response to the information security incident that poses a risk of a data breach.
Applicant	A person who seeks appointment to a position in state service.
Approval Authority	The person with the authority to sign and issue a corrective or punitive action/measure as identified in the Department's Procedure 1001.03 Delegated Authority—Personnel Rules.
Approving Official	An individual authorized for approving disbursement of agency funds for his/her assigned cost center(s).
Arizona Criminal Justice Information System (ACJIS)	A computer database system that serves as the state repository for criminal records in the State of Arizona and assists law enforcement personnel in conducting background checks.
Arizona Financial Information System (AFIS)	The principal automated system for accounting and financial reporting of the State.
Arizona Health Care Cost Containment System (AHCCCS)	Arizona's Medicaid program designed to deliver quality health care under cutting-edge concepts of managed care.
Arizona Law Enforcement Telecommunications System (ALETS)	A telecommunications system that provides for the exchange of criminal justice information between terminals within the State of Arizona.

Arizona State Employee Drivers Record Application (ASEDRA)	A web based application, was developed in 2009 to facilitate State agencies in obtaining Motor Vehicle records of State employees identified as authorized drivers in accordance with the AAC Rule R2-10-207.12. To expedite the Motor Vehicle Record (MVR)-review process, ASEDRA allows agencies to access thousands of records on a regular basis. The designated Agency representative receives notification when points on a MVR exceed a preset point value or the employee's license is either suspended or revoked.
Arizona State Forestry Division	A division of the Arizona State Land Department that provides for the prevention and suppression of wildland fires on state and private lands located outside of incorporated municipalities.
AS400	Contains more detailed delinquency information than the JOLTS Data Warehouse access permits the user to obtain.
Assault	Intentionally, knowingly, or recklessly causing or attempting to cause any physical injury to another person; including the use of bodily fluids to injure or infect another person. Includes employees assaulted by juveniles, and juveniles assaulted by juveniles.
Assessment and Documentation:	<p>Red Folder: A red colored folder containing documentation in chronological order pertaining to a juvenile's precautionary status while the juvenile is on Suicide Prevention Status (SPS). The purpose of this folder is to provide historical and ongoing information to employees monitoring and observing the juvenile while on precautionary status;</p> <p>Initial Precautionary Risk Assessment (IPRA): The standardized interview of a juvenile conducted when there is evidence that the juvenile poses a threat to him/herself or others. This assessment shall be conducted by the Qualified Mental Health Professional (QMHP);</p> <p>Crisis Intervention Assessment (CIA): A formalized follow-up assessment completed every 24 hours on any juvenile assessed at Suicide Risk Level 1, 2, or 3. This assessment shall be conducted by a QMHP.</p>
Asset	A useful and valuable resource.
Attempted Escape	Any instance in which a juvenile is apprehended prior to his/her unlawful departure from an institution or from custody while being transported. To be distinguished from a juvenile being out of area.
Automated COMPSTAT	The computer based platform that secure facility leadership uses to analyze safe environment issues for the previous two week period at the facility, to input action plans that are tracked to completion, and to generate a report used at the bi-weekly COMPSTAT meeting.
Automated External Defibrillators (AEDs)	Electronic devices that interpret cardiac rhythms and, if appropriate, deliver an electrical shock to the patient.
Authority	Lists specific statutes, rules, codes and regulations that authorize and/or guide the Department's activities in a given area. This heading is omitted if the only authority is A.R.S. 41-1604, duties and Powers of the Director. In the introduction to the policy this statute is identified as authority for the entire system of written instructions.
Authorized Personnel	A sworn, certified Special Investigator trained by Arizona Peace Officer Standards and Training (AZ-POST) meeting AZ-POST training requirements with all firearms they are authorized to carry during the performance of their duties. Also, Parole Officers certified by an ADJC certified firearms instructor and the Director to carry a firearm during the performance of their duties.
AZ POST	Arizona Peace Officer Standards and Training.

Basic Hygiene Items	<p>Items distributed to the juvenile when s/he enters secure care. The same items are continuously supplied to the juvenile when his/her supply is depleted. These items include the following, all of which shall be appropriate to the user, free of individual allergens, and may sometimes be stored in the office or Control Room:</p> <ul style="list-style-type: none"> a. 1 shaving razor (always stored in office); b. 1 shaving cream (always stored in office); c. 1 toothbrush; d. 1 toothpaste; e. 1 shampoo; f. 1 conditioner; g. State issued ethnic specific hair products; h. 1 deodorant; i. 1 comb/pick (soft plastic only); j. 1 hairbrush (female only, soft plastic only); k. 1 roll of toilet paper; l. 1 bar soap; and m. 1 hair tie for juveniles who are allowed to wear their hair long (black, white, or gray in color only).
Basic Orientation	<p>An orientation that is provided on the first day of employment and includes information necessary for the health employee (for example, full-time, part-time, consultant, and contract) to function safely in the ADJC facility.</p>
In-Depth Orientation	<p>This orientation includes full familiarization with the health services delivery system at the facility and focuses on both the similarities and the differences between providing health care in the community and in a secure care setting.</p>
Batterer, Perpetrator or Abuser:	<p>The individual who commits an act of domestic violence or sexual harassment.</p>
Best Practice Standards that include but are not limited to North Central Accreditation (NCA), National Commission on Correctional Health Care (NCCHC) and American Correctional Association (ACA) Standards	<p>For Youth Correction and Detention Facilities shall be utilized as guidelines for self improvement and accountability to improve the quality of life for juveniles in custody.</p>
Betterment	<p>An addition made to, or change made in, a capital asset, which is expected to prolong its useful life, to alter its original functionality, or to increase its efficiency over and above the effects arising from repairs and maintenance. The cost of a betterment that meets or exceeds the State's capitalization threshold is therefore added to the book value of the original asset to or into which the betterment is added, affixed, or installed. The term "betterment" is not deemed to include building improvements, land improvements, or leasehold improvements.</p>
Bilingual Education/Native Language Instruction	<p>A language acquisition process for students in which much or all instruction, textbooks, or teaching materials are in the student's native language other than English.</p>

Blog	A self-published diary or commentary on a particular topic that may allow visitors to post responses, reactions, or comments. The term is short for "web log."
Brady List	An integrity list containing names of employees in the Youth Correctional Officer series, in the Youth Program Officer series, the Security Officer series and Administrators who have been disciplined for integrity violations. This list is given to the County Attorney who discloses the names to other trial attorneys.
Brand Name Determination	Used when it is determined that only an identified brand name item will satisfy the state's need. An ADJC employee may request, in writing, the use of a brand name specification to the ADJC PROCUREMENT ADMINISTRATOR including the following information: a) An explanation of why only an identified brand name item will meet the state's need; b) The name of the proposed supplier; c) The duration and estimated total dollar value of the proposed procurement; d) A description of efforts made to seek other sources.
Breath Alcohol Technician	A contract person certified by the Department of Transportation to operate and read a breath analyzer or similar testing machine utilized to perform a breath alcohol test.
Building Improvements	Fixtures, machinery and other items attached to or installed in State-owned buildings in such a way that they cannot be removed without causing damage to themselves or the buildings to which they are affixed.
Bulletin Board	Sign holders that are a frame always attached to the wall used to display temporary directional signs or signs advertising for information on facility events or programs and/or environmental quality compliance notices. A board or panel designated for posting approved solicitation announcements and materials. This includes the Electronic Bulletin Board (EBB).
Business Day	The hours between 8:00 a.m. and 5:00 p.m., Monday through Friday, excluding observed state holidays.
Call Back	The ADJC Director or designee may approve the time a covered and/or non-exempt uncovered employee is called into work before or after his/her standard workday (not a continuation of the shift) or during a regular day off if the employee is not already at the work site.
Call-Out	A mobilization of support crews by the Arizona State Forestry Division in the event of a wildland fire.
Camp Medic	An emergency medical technician or higher level practitioner provided by the Arizona State Forestry Division to administer emergency medical care for crew members.
Candidate	A person whose knowledge, skills, and abilities (KSAs) meet the requirements of a position who may be considered for employment and/or is seeking to be nominated to serve as a volunteer, mentor, chaplain, or intern within the organization. A current departmental employee in a non-designated position who transfers or applies for a designated position within the department is subject to a pre-employment drug test.
Canine	Same as service dog or K-9
Capital Assets	An asset with a value of \$5,000 or more purchased by the department. A long-lived tangible or intangible asset that meets the capitalization threshold of \$5,000 or more that is reported on the balance sheet and the cost of which is to be recovered over several fiscal years.

Capital Offense	A capital offense is any commission of a Class One, Class Two, or Class Three felony that results in the loss of life.
Capital Renewal	Is the upgrading or replacement of facilities, major building systems, and supportive infrastructures.
Case Management Personnel	Employees who directly or indirectly supervise and/or provide services to juveniles.
Caustic material	A substance with the capability of destroying or eating away by chemical reaction
Cautionary Status	The procedure of observing and documenting a juvenile's activities at staggered intervals not to exceed 15 minutes, in accordance with Procedure 4250.01 Suicide Prevention Procedure.
Central Office Benefits Liaison	A Central Office Personnel employee who is knowledgeable about the processes of application for employee benefits.
Certified Firearms Instructor	An individual trained in accordance with national law enforcement firearms training standards and approved by the ADJC Director.
Chain-Of-Custody for Testing	A process used to account for the integrity of each specimen by tracking the handling and storage from point of collection to the final disposition.
Chemical Agents	The use of chemical agents is considered a less lethal tactic. Oleoresin Capsicum (Cayenne Pepper) is a less lethal weapon designed to disrupt the intended thought process, with no lasting after effects. Oleoresin Capsicum is commonly referred to as OC or pepper spray.
Child	<ol style="list-style-type: none"> 1. For purposes of R2-5-416(C), pertaining to the health benefit plan, R2-5-418(B), pertaining to the retiree health benefit plan, and R2-5-419(C), pertaining to the health benefit plan for former elected officials, an unmarried person who falls within one or more of the following categories: <ol style="list-style-type: none"> i. A natural child, adopted child, or stepchild who is younger than age 19 or younger than age 25 if a full-time student; ii. A child who is younger than age 19 for whom the employee-member, retiree, or former elected official has court-ordered guardianship; iii. A foster child who is younger than age 19; iv. Child Abuse	<p>Under circumstances likely to produce death or serious physical injury, any person who causes a child to suffer physical injury or, having the care or custody of a child who causes or permits the person or health of the child to be injured or who causes or permits a child to be placed in a situation where the person or health of the child is endangered is guilty of an offense. The terms endangered and abuse include but are not limited to circumstances in which a child is permitted to enter or remain in any structure or vehicle in which volatile, toxic, or flammable chemicals are found or equipment is possessed by any person for the purpose of manufacturing a dangerous drug. ARS §13-3623.</p>
Child Abuse Assessment/Child Advocacy Centers	<p>Centers in Maricopa and Pima County that are specially designed to help reduce the trauma to a juvenile victim by offering services such as forensic medical exams.</p>
Child Molestation	<p>As defined in ARS 13-1410: By intentionally or knowingly engaging in or causing a person to engage in sexual contact, except sexual contact with a female breast, with a child under fifteen years of age.</p>
Child Protective Services (CPS)	<p>A program mandated under ARS §8-802 for the protection of children alleged to be abused and neglected. This program provides specialized welfare services that seek to prevent dependency, abuse and/or neglect of children. The Child Protective Services program receives, screens and investigates allegations of child abuse and neglect, performs assessments of child safety, assesses the imminent risk of harm to the children and evaluates conditions that support or refute the alleged abuse or neglect and need for emergency intervention.</p>
Chores	<p>Routine, uncompensated tasks around the housing unit and its immediate area which concern the daily upkeep of the unit which may include:</p> <ol style="list-style-type: none"> 1. Housekeeping; 2. General cleaning; 3. Laundry; 4. Yard work; 5. Washing windows; 6. Cleaning room; 7. Sweeping, mopping, and vacuuming.
Chronic Disease	<p>An illness or condition that affects an individual's well-being for an extended period of time, usually (at least) six months, and generally is not curable but can be managed to provide optimum functioning within any limitations the conditions imposes on the individual.</p>
Claim	<p>An application for compensation submitted under article R10-4-101.</p>
Classification and Reception Administrator	<p>Oversees the statewide delivery of case management services, classification, and records.</p>

Clinical Performance Enhancement	The process of having a health professional's work reviewed by another professional of at least equal training in the same general discipline, such as the review of the facility's physicians by the responsible physician.
Clinical Review	A qualitative review of clinical services that is conducted by a board eligible/state licensed Qualified Mental Health Professional (QMHP). The review focuses on the QMHP's clinical skills and policy and procedure compliance.
Close Observation	Visual observation of designated juveniles at staggered intervals to ensure the juvenile's safety.
Collection Site	An area within a facility designated for the collection of urine specimens, a medical facility, doctor's office, or hospital authorized by the department to collect a urine specimen for analysis to detect the presence of drugs. Collection sites shall be contracted through the drug testing laboratory contractor.
Collection Site Representative	A person employed by a collection agency or site who may travel to different department facilities to assist and instruct individuals directed to provide a urine specimen. The collection site person is trained to receive and make the initial examination of urine specimens to include the proper packaging and sealing of the specimen in front of the employee.
Committed Juvenile or Juvenile	Means a person who is eight years of age or older but who has not yet attained the age of eighteen years and who according to the law has been committed to the Arizona Department of Juvenile Corrections for supervision, rehabilitation, treatment, and education.
Commitment Checklist	A list of documents to be transmitted to ADJC for juveniles committed by the juvenile courts. It is the same list used by the Reception, Assessment, and Classification personnel to check that all required documents arrived with the juvenile and to meet all legal and departmental standards for admission.
Compact Administrator	The individual in each compacting state who is appointed in accordance to the terms of this compact and who is responsible for the administration and management of the state's supervision and transfer of juveniles who are subject to the terms of this compact, the rules adopted by the interstate commission and policies adopted by the state council under this compact.
Compacting State	Any state or territory of the United States that has enacted the enabling legislation for this compact.
Compel movement	The physical force used to cause the movement of a person from one location to another.
Compensation Award	A payment made to a claimant under the standards at R10-4-108.
Compensatory Instruction	Instruction given in addition to regular classroom instruction, such as: individual, small group, extended day classes, summer school or intersession school.
Complainant	The employee(s) who file a complaint
Complaint Receipt Acknowledgment Letter	A written acknowledgment of the complaint that will be provided to the complainant.
Complaint Response Letter	A written notification of the investigative findings from an administrative investigation that will be provided to the complainant.
Completed Suicide	A death resulting from a suicide attempt. The intervention and follow-up for completed suicides is outlined in Procedure

Comprehensive Review	A qualitative and quantitative review of the delivery of behavioral health, psychiatric, and medical services conducted by the Medical and Behavioral Services Clinical Director or designee.
COMPSTAT (Computer Aided Statistics)	<p>A system designed for the collection and feedback of information on crime and related safety issues. The COMPSTAT process enables agency personnel to collect, analyze, and map incident data and other measures on a regular basis, and holds managers accountable for their performance to encourage successful outcomes and a safe environment for juveniles and employees. It is a system that allows direct information exchange between the facilities and the agency leadership. Key components of the COMPSTAT process are:</p> <ol style="list-style-type: none"> a. Accurate and Timely Information: effective control of safe environment issues in the facilities requires accurate and timely information: <ol style="list-style-type: none"> i. When (time of day, day of week, week of year) various types of incidents have been committed; ii. How various types of incidents have been committed; iii. Where various types of incidents have been committed; and iv. By whom they have been committed. b. Effective Tactics: having automatically collated, analyzed and mapped this information, action plans are developed for dealing with the problems. These action plans: <ol style="list-style-type: none"> i. Are comprehensive, flexible, and adaptable to changing trends; ii. Involve all stake holders at all levels within the organization, facility leadership, education, youth rights, mental and medical health services, etc.; and iii. Identify the issue, the plan, the responsible person to carry out the action plan, estimated completion time, and the actual completion time. c. Deployment of Personnel and Resources: once an action plan has been developed, the deployment of personnel and resources is rapid and focused; d. Ongoing Follow-up and Assessment: all action plans are reviewed on an ongoing basis and assessed to ensure that the desired results have been achieved.
Dynamic COMPSTAT	A juvenile-focused system utilizing user-friendly data screens to display incident details.
Conditional Release	The release of a juvenile under special conditions as specified by the court or agency of jurisdiction.
Consent	<ol style="list-style-type: none"> 1. The <u>parent</u> is fully informed of all information relevant to the activity for which consent is sought in his or her native language or other mode of communication; 2. Employee/Volunteer Service Provider	For the purpose of this policy, an employee refers to all full and part time employees and includes volunteers, chaplains, mentors, and interns who provide services to the department with or without compensation.
Employment Discrimination	Any personnel transaction/employment decision that has an adverse effect, whether intentional or unintentional, on a member of a protected group under the law (race, color, sex, religion, national origin, disabled veteran status, age, disability status, veteran status or political affiliation).
Empty Hand Control	A method of control used without the aid of equipment or weapons:

Errors in form may include corrections made when updating organizational structure, such as changing a title or proper name. An error in form does not include any item that changes meaning or content and shall not be so extensive that significant corrections are needed. Typically, an error in form would require no review and may be corrected without the Director's signature through a publication announcement distributed by the Policy Unit.
Escape	The unlawful departure of a juvenile from an institution or from custody while being transported, or failure to return to the facility while on leave.
Escape Risk	When there are reasonable grounds to believe that a juvenile is a serious and continuing threat to escape, based upon demonstrated intent, actions, and a reasonable possibility to succeed.

Hours of Service	The number of hours actually worked; does not include any type of paid or unpaid leave with the exception of military leave.
Hunting	Drive to pursue prey or objects.
Immediate Family Member	The recipient employee's parent, spouse, or child, whether natural, adopted, foster, or step.
Immediate Threat	The subject poses a risk of instant harm or attack with the elements of jeopardy, opportunity, and ability.
Immigration and Customs Enforcement (ICE)	An investigative branch of the Department of Homeland Security (DHS). The agency was created by combining the law enforcement arms of the former Immigration and Naturalization Service (INS) and the former U.S. Customs Service, to more effectively enforce our immigration and customs laws. ICE does this by making use of its resources and expertise to transport aliens, to manage them while in custody and waiting for their cases to be processed, and to remove unauthorized aliens from the United States when so ordered. ICE assists ADJC in coordinating the release of juveniles to Conditional Liberty status in the United States or repatriates juveniles in a humane and dignified manner.

Individualized Re-Integration Plan	An individual plan designed to allow a juvenile to transition successfully from Separation to regular programming.
Infection Control Practices	Defined by the American Dental Association and Center for Disease Control and Prevention as including sterilizing instruments, disinfecting equipment, and properly disposing of hazardous waste.

Intern	Person who provides services to juvenile with or without compensation as a part of formal education program supervised by an approved institution of learning.
Internal Complaint	Allegations made by an employee directed at specific misconduct on the part of another employee.
Interpandemic Period	<ul style="list-style-type: none"> a. Phase 1. No new influenza virus subtypes have been detected in humans. An influenza virus subtype that has caused human infection may be present in animals. If present in animals, the risks of human infection or disease are considered to be low; b. Phase 2. No new influenza virus subtypes have been detected in humans. However, a circulating animal influenza virus subtype poses a substantial risk of human disease; c. The distinction between phase 1 and phase 2 is based on the risk of human infection or disease resulting from circulating strains in animals. The distinction is based on various factors and their relative importance according to current scientific knowledge. Factors may include pathogenicity in animals and humans, occurrence in domesticated animals and livestock or only in wildlife, whether the virus is enzootic or epizootic, geographically localized or widespread, and/or other scientific parameters.
Interpreter	Someone who translates orally. They interpret what someone says into another language. The key skill of an interpreter is the ability to translate in both directions, in real time, without using dictionaries or other supplemental reference materials. Interpreters must have extraordinary listening abilities and the intellectual capacity to instantly transform idioms, colloquialisms and other culturally specific references into analogous statements the target audience will understand.
Interstate Compact for Juveniles (ICJ)	An agreement pertaining to the legally authorized transfer of supervision and care as well as the return of juveniles from one State to another which has been adopted by all member states who have enacted legislation in substantially the same language.
Interstate Parole	A juvenile adjudicated (by a jurisdiction outside of Arizona) that is on Parole in this state, under Department supervision.
Interstate Probation	A juvenile adjudicated (by a jurisdiction outside of Arizona) that is on probation in this state, under Department supervision.
In The Line of Duty	An occurrence while the employee is on duty or is the result of performing any function in an official Departmental capacity.
In-the-Line-of-Duty Death	An employee's death or incapacitating injury that occurs while the employee is on duty or is the result of performing any function in an official Departmental capacity. The final determination of whether an employee's death is in the line of duty shall be made by the Director.
Intra-Agency Transfer	The movement of an employee from one position in the Arizona Department of Juvenile Corrections (ADJC) to another position

Medical Review Officer	A certified, licensed physician who reviews laboratory positive drug test results. Play	Drive for physical contact with pack member (handler).
Policies	The primary method for management to communicate its philosophy, intent and expectations to employees, juveniles and the public. The only written instructions authorized for development are Director's policies and procedures, forms, technical manuals and administrative memos. Issued under the Director's signature, these written instructions cross organizational lines to guide the uniform administration and operation of the Department. Based on a systems approach, each policy, procedure and form comprehensively addresses a specific topic. Policies are organized with major section headings and subsections as follows: Policy number 1105 ; Procedure and Form indexes - First major section may include definitions
Policy Analyst	Is a person who is involved in the evaluation and formulation of policy. A policy analyst examines existing policy and is involved in research designed to identify what needs to be addressed with new policy. This work can include compiling statistics, reading reports and synthesizing the information into a meaningful document and helping with the actual drafting of policy language.
Position	A job that is filled by a specific employee (for example, medical records librarian, physician, chief nurse, etc.). A position has a <i>position description questionnaire (PDQ)</i> that is on file with ADJC Human Resources.
Positional Asphyxia	The reduction in oxygen in the bloodstream and tissues due to an impairment of a person's respiratory system caused by body positioning or the application of external weight/pressure, resulting in death. Predisposing factors include obesity, alcohol/drug use and enlarged heart.
Positive Drug Test Result	Test results that conclude that both the initial and confirmation test-drug(s) and metabolite(s) tested for are at or above the cut-off level(s).
Post	A job defined by its location, time, and duties that can be filled by different employees (for example, 7-3 infirmary nurse). Continuous coverage usually distinguishes a post from a position; a post has tasks that cannot usually be deferred.
Post Offer Drug Test	A urine drug test taken by the candidate as a condition of employment.
Practicable	Something that is doable or feasible.
Preclusion	Elimination of all lesser means of control/force. The lesser means of control/force have been tried and they have not been effective or the type of resistance is greater than the method of control/force.
Predatory Behavior	Behavior that victimizes, plunders, or destroys, in a preying manner and possibly for self-gain.
Prescribing Provider	A person licensed by the State of Arizona such as a Medical Doctor (MD)/Doctor of Osteopathic Medicine (DO), Nurse Practitioner (NP), or Physician's Assistant (PA), or Doctor of Dentist Surgery (DDS) who is authorized to write prescriptions.

Section 504 of the Rehabilitation Act of 1973	States that "no qualified individual with a disability in the United States shall be excluded from, denied the benefits of, or be subjected to discrimination under" any program or activity that either receives Federal financial assistance or is conducted by any Executive agency or the United States Postal Service.
Secure Care or Secure Facility	Means confinement in a facility that is completely surrounded by a locked and physically secure barrier with restricted ingress and egress.
Self-Defense	Drive to bite real or imagined danger.
Self Injurious Behavior	An act performed with the apparent intention to cause injury but not death. Examples include: self-inflicted superficial scratches, cutting/scratching one's self with a comb or eraser, tattooing, head-banging, biting, bruising, hitting, picking/pulling scabs, or ingesting of foreign substances or objects with the intent to cause injury but not death. The intervention and follow-up for self injurious behavior is outlined in Procedure 4250.01 Suicide Prevention Procedure.
Self-Referral; Self Referral to	Upon a juvenile's own request employees may not refuse to refer a juvenile to Separation unless a specific behavioral contract

Sick Call	The face-to-face evaluation, generally performed by a QHCP.
Signs, Signage	<p>Any identification, description, illustration, or device that is visible from any public place or is exposed to the public, and which directs attention to a product, message, service, place, person, entity, institution, event, business use, or cause. Categories of signs or signage include:</p> <ul style="list-style-type: none"> i. Stable and Cooperative	A juvenile is considered stable and cooperative when a Qualified Mental Health Professional determines s/he: a. Is rational in the present time; and b. Demonstrates pro-social attitudes, behavior, and speech.
Staffing Plan	A plan, that lays out the full-time equivalent(FTE) of employee coverage required, lists current incumbents and vacancies, and addresses how full coverage will be accomplished if all positions are not filled (for example, use of agency, temporary, or part-time employee). A staffing plan is a detailed schedule on which classifications of employees are assigned to posts and positions for delivery of health services.
Staggered Intervals	An irregular and unpredictable schedule in order to promote the juvenile's safety.
Standard Precautions	As defined by CDC, are a set of precautions designed to prevent transmission of human immunodeficiency virus (HIV), hepatitis B virus (HBV), and other bloodborne pathogens when providing first aid or health care. Under standard precautions, blood and certain body fluids of all patients are considered potentially infectious for HIV, HBV, and other bloodborne pathogens.
State	A state of the United States, the District of Columbia or its' designee, the Commonwealth of Puerto Rico, the United States Virgin Islands, Guam, American Samoa and the Northern Mariana Islands.
Static	Refers to unchangeable historical reflection of risk.

This behavior may include statements of suicidal behavior, gestures, threats, and tattoos denoting suicidal intent, ingestion of medication of substance with the intent to cause serious harm or death. Truth Verification Examinations	An examination utilizing a validated instrument and/or investigative technique such as the polygraph or Computer Voice Stress Analysis to assist in verifying the integrity and accuracy of the information provided during an investigation.

Victims of Crime Act (VOCA)	Established in 1988 through an amendment to the Victims of Crime Act (VOCA) of 1984, the Office for Victims of Crime (OVC) is charged by Congress with administering the Crime Victims Fund (the Fund). Through OVC, the Fund supports a broad array of programs and services that focus on helping victims in the immediate aftermath of crime and continuing to support them as they rebuild their lives.
Violent Behavior	Physical force exerted for the purpose of violating, damaging, or abusing: crimes of violence, expression of physical force against self or other, compelling action against one's will, or pain of being hurt.

Wildland Fire Support Camp Duties	Tasks essential to the basic function of a fire camp to include but not limited to: loading and unloading of supplies, assembling tents and equipment, tool check out and repair, garbage collection, food and water dispersal, basic cleaning, raking ground, digging drainage ditches, and scullery duties.

Name of the Definition	Description of the Definition
Wildland Fire Support Team	Acts in support of the Arizona State Forestry Division or other contracted governmental agency in the development of forest trails, pre-cut fire line, camp ground clean up, and other duties as directed.
Work Areas	All areas maintained by or for the use of a state agency, department, bureau, or unit where employees or officers conduct official state business. Cafeterias and break rooms are not work areas.
Work-related	Related to an employee's present or prior employment at ADJC or other state agency.
Working Dog Team	A working dog and handler, trained to work together in performing their specialized mission.
Youth Banking System	A bookkeeping system on individual juvenile accounts to ensure all juvenile monies are accounted for and returned when a juvenile is released from a secure school.
YPO III Case Manager	An unlicensed provider with education, training, and experience adequate to perform case management services and other select clinical duties required under the clinical supervision of the QMHP, in accordance with professional standards, as authorized by the designated mental health authority.
